Please complete all components of this form to apply for a booth at the Mid-South’s CHICK DAYS EVENT so that we may serve you as well as possible. The event will be held on Saturday, April 14th from 8:00 am- 3:00 pm.

Terms and Conditions:

- Booths are rented on a first come, first serve basis. We reserve the right to limit the number of Direct Sales Vendors and also reserve the right to limit the number of vendors in a particular category
- The Chick Days Event Coordinator may choose to deny a vendor based on appropriateness of products and duplication of vendors. Vendors may not sell any type of alcoholic beverages of any kind, or any products that are deemed to be anti-American.
- You can set tables and tents up beginning at 2PM, Friday April 13th. (We do not recommend leaving merchandise in booths overnight) If you do not set up booths on Friday, you can start setting up at 7:00AM on Saturday, April 1st. **ARRIVE EARLY!! THE MORNING OF THE EVENT WILL BE HECTIC WITH VEHICLES.**
- Booth sizes are 10 x 10 and will be outdoors a **\$15.00 non refundable fee for single 10’x10’ vendor space (\$30 for Food Vendors)** - *Insurance with “Mid-South Lumber Co. of NW FL Inc.” listed as additional insured is required*
- **Electrical access is an additional \$ 10.00 fee. NOTE: Electrical access is very limited and will be approved on a first come, first serve basis. We WILL run out of Electrical Spaces, so book early & get approval for electric!**
_____ Yes, I require electrical access and am including an additional \$10 vendor fee. (you will need to bring your own electrical cords and extension cords)
- Participants are responsible for bringing their own tables, chairs etc...and the set-up and clean up of their area.
- **Cancellation Policy: This event will be held regardless of rain or shine. Booth space fees are non-refundable unless Mid-South Lumber cancels the event.**
- Vendors keep all profits from their booths. **Vendors are required to stay for the duration of the event. No breaking down early or you will not be allowed to participate in any future MSL events.**
